A-1 "Holistic Advocacy: Working the Intersection of Domestic Violence and Child Wellbeing"

Chloé McMurray, Chief Capacity Building Officer, Illinois Coalition Against Domestic Violence

Because domestic violence is present in 30 to 60% of child welfare caseloads nationally and is one of the three most common circumstances present in the lives of families coming into state care, domestic violence cases in the child welfare system are some of the most complex and difficult cases for child welfare workers to navigate. Despite these facts, partnerships between child welfare services and domestic violence programs have not shown up until recent years.

A-2 "Combating Child Abuse with CANVA"

A-3 "Moving Prevention Forward: An Equity-Centered Approach"

"I want to be a good mom"--- heavy words reflecting a deep desire of parents all over the world. But what happens when being a "good mom" doesn't come naturally? What happens when a person's motherhood is overshadowed by challenges such as substance misuse, mental health, and addiction? This workshop will dive into the unique experiences of mothers impacted by addiction and trauma, and discuss how societal definitions and expectations specific to motherhood can often create barriers to treatment and recovery.

++ A-5 "Both Sides of the Door: Learning from Home Visitors and Doulas Who Have Been Participants"

Dara Williamson, Bridget Lally and Jess Jobe, Start Early HFI/ Doula Team Members This workshop is a facilitated conversation with home visitors and doulas who have previously participated in a home visiting program. We'll learn from their lived experience more about the family's perspective and how home visiting programs can partner more effectively with families.

++ A-6 "Empowering Families through Parenting and Caregiving Education."

Katharine Bensinger, Founder and CEO, ParenTeach Institute Stephanie Starr, Director of Education, ParenTeach Institute

Our target audience is child welfare staff, home visitors, educators, medical practitioners, and social workers/ counselors. We cover why positive caregiving education is critical and introduce ParentABLE's 6.5-hour positive parenting and caregiving unit. Participants will view portions of ParentABLE, hear facilitator feedback, and leave with a clear understanding of the course content, an appreciation of the evidence that supports the need for positive parenting and caregiver education, and how to offer ParentABLE.

B-1 "A New Approach to Child Abuse Prevention: Public Health, Partnership, and Well-Being"

Melissa Box, LCSW, MPH, Family First Prevention Administrator, Illinois Department of Children and Family Services

The state of Illinois has a long history of public and private partnership to support community initiatives focused on the prevention of child abuse and neglect. But how much of what we call "prevention" actually prevents child abuse and neglect? This presentation will outline current DCFS prevention programs, including community-based services and concrete supports. The implementation of the Family First Prevention Services Act, its successes, challenges, and current data, will also be discussed. Future plans, including how attendees can have a voice as stakeholders in statewide plans and implementation, will be presented. Collaboration across sectors, across state agencies, and across communities will be highlighted as central to all of these efforts.

B-2 "Fatherhood Coalitions—a Game-Changer for Fatherhood Programming in Illinois?"

Earl L. Kloppmann, Program Manager, Advancing Fathers Program, Brightpoint

After years of frustration about developing father support groups, The Parents Care & Share program attempted a new approach to fatherhood programming—getting the community involved and aligned around fatherhood first. The result was way beyond their expectations! They are convinced the model they are developing during an initial three-year pilot could be the game changer for greater effectiveness in fatherhood service delivery that Illinois needs.

♦♦ B-3 "Advancing Health Equity in Sexual Violence"

Kasey Pryer (she/her), ICASA Prevention Coordinator, Illinois Coalition Against Sexual Assault

Corrin McWhirter (she/her), ICASA Chief Operating Officer, Illinois Coalition Against Sexual Assault

Health equity is the current buzz word in prevention, but it is not new. The core ideas are the roots of sexual violence prevention. Join Kasey and Corrin from the Illinois Coalition Against Sexual Assault to strip down the jargon, deepen understanding, and develop tangible action to incorporate health equity into sexual violence prevention. This session is tailored for professionals, educators, and community leaders committed to creating safer, more inclusive environments.

++ C-5 "Trauma-Informed Approaches in Home Visiting: NEAR@Home"

Research shows there are higher rates of adversity and trauma exposure for participants in child protective services and home visiting programs compared to the general population. Home visiting programs have a unique opportunity to provide safe, effective and respectful discussions with families about trauma and adversity in early childhood. This session will focus on foundations of trauma-informed practice, how trauma-informed practice fits within the home visiting field, and will share a bit about one innovative program: NEAR@Home, which is a framework that uses trauma-informed practices in home visiting.

++ C-6 "Perinatal Mood Disorder Support & Prevention"

Rachel Chruszczyk, Southern Region Prevention Specialist, Prevent Child Abuse Illinois

D-1 "Navigating the Nexus: Supporting Transitional Aged Youth"

Brittany Watson, CRSS, MHP, President of SWSA, Southern Illinois University Carbondale, School of Social Work

"Navigating the Nexus" explores critical strategies for aiding youth in their transition to adulthood. The presentation includes a personal vignette and timeline based on lived experiences featuring work from my published manuscript. We will also examine comprehensive data on trauma experiences and complex trauma in youth aged 14-25, and consider several supportive methods to enhance our approach and systems of care when serving youth of this demographic.

D-2 "Addressing Children's Grief within a "Circle of Care"

Nancy Phillips, Program Coordinator, Illinois Family Resource Center

With the escalation of drug overdoses and opioid issues, along with an increase of children being removed from the home due to substance misuse, a sense of grief is increasing for our young children and teens. As a result, Family Resource Center is working on a year-long project, the Circle of Care, for children. Learn about Circle of Care within organizations, communities, schools, and faith-based groups. Be a part of the statewide efforts to build grief management for youth within a Circle of Care!

D-3 "LGBTQ+ Inclusion: Where do I even begin?"

Shannon Green, Healthy Families Program Coordinator, Shawnee Health

This workshop will review basic concepts and terminology related to LGBTQ+ issues in early childhood and home visiting settings. Participants will have the opportunity to think together, ask questions, explore ideas, reflect on concerns and fears, and foster optimism for creating inclusive spaces for LGBTQ+ people in all aspects of our work.

⇔ D-4 "Family Human Trafficking and the Connection to Drug Endangered Children"

Liesl Wingert, BS, MHA, Program Coordinator, East Region - SIU School of Medicine-Center for Rural Health and Social Service Department

Family human trafficking is the hidden process of exchanging a family member for goods, substances, rent, services, money, or status within the community. Roughly 90% of trafficking actually begins in the home, with over 80% of family trafficking revolving around illegal drugs. Familial trafficking is more easily hidden, especially in rural areas, and often begins with the smallest of children in the home, thus causing a unique psychological crisis of trauma that extends into adulthood. This workshop will delve into this topic in detail.

++ D-5 "Parent Engagement & Addressing Disparities in Home Visiting"

Abby Snow, LSW, Center for Prevention Research and Development

Tuyen Bui, Ph.D., MSW, Center for Prevention Research and Development

The workshop will cover ideas from the 2023 IDHS-DEC Home Visiting Staff survey completed by the home visiting workforce. The survey results will be used to share home visitor's tools for parent engagement and learn elements of addressing disparities. The audience will also have the opportunity to collaborate with staff in the room to discuss practical steps at the agency level.

++ D-6 "The Impact of Doula Home Visiting on Maternal and Infant Health"

Chastity Mays, M.S.Ed., CD(DONA), Hathor Doula Services and The Little Resource Center Carbondale

The workshop will discuss a home-visiting model that incorporates doulas into the intervention team, demonstrates improvements in childbirth preparation, breastfeeding initiation, safe sleep practices, and early car-seat use. Growing evidence shows that childhood home-visiting programs for socially and economically vulnerable families can have impacts in multiple areas, including maternal and child health, parenting, child development, and family economic self-sufficiency.
